THE ROAD TRANSPORT ACT 1987

THE ROAD TRANSPORT (PROVISION OF PARKING PLACES) (CITY OF KUCHING NORTH) (AMENDMENT) ORDER, 2007

(Made under section 72)

In exercise of the powers conferred by section 72 of the Road Transport Act 1987 [Act 333], the Commission of the City of Kuching North, being declared an appropriate authority under section 67 of that Act [P.U. (B) 289/92], has made the following Order:

Citation and commencement

 This Order may be cited as the Road Transport (Provision of Parking Places) (City of Kuching North) (Amendment) Order, 2007, and shall be deemed to have come into force on the 1st day of January, 2007.

Amendment of article 2

 Article 2 of the Road Transport (Provision of Parking Places) (City of Kuching North) Order, 2005 [Swk. L.G. 48/2005] (the "Principal Order") is amended—

- (a) by inserting after the definition "Commission" the following new definition:
 - ""Commission's agent" means any company, body, firm, corporation or institution appointed or engaged by the Commission to carry out the functions and duties as stipulated under article 13A;";
- (b) by inserting immediately after the definition of "parking" the following new definition:
 - " "parking control" means all the services and facilities which the Commission's agent may be required to provide to the Commission, and includes the provision of office, office personnel staff, parking wardens and equipments or mechanism that are necessary to carry out the parking control services effectively;"; and
- (c) by substituting the full stop at the end of the definition of "sign" with a semi-colon, and by inserting immediately after that the following new definition:
 - " "State Minister" means the State Minister in Sarawak charged with the responsibility for the Commission.".

Amendment of article 3

- 3. Article 3 of the Principal Order is amended-
 - (a) by substituting paragraph (2) with the following:
 - "(2) The Commission may, with the approval of the State Minister, by notification in the *Gazette*, amend the Schedules specified in paragraph (1)."; and
- (b) by inserting immediately after paragraph (3) the following new paragraph (3A):
 - "(3A) The Commission may, with the approval of the State Minister, impose prescribed parking fees in accordance with the rates as stipulated in the Order for half hourly or hourly parking, in any public road or place vested in the Commission for use as a public road or car park but which has not been included in the First Schedule or Second Schedule to this Order, by publishing the appropriate notice in any local newspaper and erecting the appropriate sign board in respect thereof in the immediate vicinity of such public road or place, and the provisions of this Order shall apply thereto."

Amendment of article 4

4. Article 4 of the Principal Order is amended by substituting the words "shall, with the approval of the Minister, to determine" in lines one and two of paragraph (1) with the words "shall, with the approval of the State Minister, have the discretion to determine".

New article 13A

5. There shall be added immediately after article 13 of the Principal Order the following new article 13A:

"Appointment and engagement of agent

13A. The Commission may appoint and engage any company, body, firm, corporation or institution to be the Commission's agent to manage, control and administer the system of parking control as provided in this Order and the methods of collecting parking fees by way of using parking coupon, coupons or any other systems which the Commission considers suitable."

Amendment of Second Schedule

6. The Second Schedule of the Principal Order is amended by inserting immediately after item 22 the following new items:

Amendment of Third Schedule

7. The Principal Order is amended by substituting the words "COUPON VALID FOR FIRST HOUR PARKING" in line 1 of Form A in the Third Schedule with the words "COUPON VALID FOR FIRST HALF HOUR PARKING".
