KAEDAH-KAEDAH PENGANGKUTAN JALAN (BANDARAYA KUCHING UTARA)  
(FEE PENGALIHAN DAN PENAHANAN KENDERAAN MOTOR) 1996

Pada menjalankan kuasa yang diberikan oleh subseksyen 65(7) Akta Pengangkutan Jalan 1987 [Akta 333], Datuk Bandar Kuching Utara, setelah berunding dengan Menteri, membuat kaedah-kaedah yang berikut:

**Nama**

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Pengangkutan Jalan (Bandaraya Kuching Utara) (Fee Pengalihan dan Penahanan Kenderaan Motor) 1996.**

**Fee**

2. Bagi maksud pengenaan fee untuk pengalihan mana-mana kenderaan motor daripada mana-mana bahagian jalan dalam kawasan Bandaraya Kuching Utara dan bagi penahanannya menurut seksyen 65 Akta tersebut, fee yang dikenakan untuk pengalihan mana-mana kenderaan motor adalah seperti yang dinyatakan dalam Jadual Pertama dan fee untuk penahanannya adalah seperti yang dinyatakan dalam Jadual Kedua.

1. Motosikal, motosikal berkereta tepi, skuter dan skuter beroda tiga	20.00
2. Motor	100.00
3. Bas, lori yang berat tanpa muatannya tidak melebihi 3000 kilogram	200.00
4. Tanker, treler dan lain-lain jenis kereta yang berat muatannya melebihi 3000 kilogram	300.00

<i>Jenis Kenderaan</i>	<i>Fee (RM)</i>
1. Motosikal, motosikal berkereta tepi, skuter dan skuter beroda tiga, motokar	5.00 sehari atau sebahagian daripadanya
2. Lain-lain jenis kereta	10.00 sehari atau sebahagian daripadanya

**ROAD TRANSPORT ACT 1987**
**ROAD TRANSPORT (CITY OF KUCHING NORTH)  
(MOTOR VEHICLE REMOVAL AND DETENTION FEES) RULES 1996**

In exercise of the powers conferred by subsection 65(7) of the Road Transport Act 1987 [Act 333], Datuk Bandar Kuching Utara, after consultation with the Minister, makes the following rules:

**Citation**

1. These rules may be cited as the **Road Transport (City of Kuching North) (Motor Vehicle Removal and Detention Fees) Rules 1996.**

**Fees**

2. For the purpose of the imposition of fees for the removal of any motor vehicle from any part of the road within the City of Kuching North and its detention in pursuance of section 65 of the Act, the fees imposed for the removal of any motor vehicle are as specified in the First Schedule and the fees imposed for its detention are as specified in the Second Schedule.

**FIRST SCHEDULE**

<i>Types of Vehicle</i>	<i>Fees (RM)</i>
1. Motorcycle, motorcycle with side car, scooter and three-wheeled scooter	20.00
2. Motor car	100.00
3. Bus, lorry unladen weight not exceeding 3000 kilograms	200.00
4. Tanker, trailer and other types of vehicle unladen weight exceeding 3000 kilograms	300.00

**SECOND SCHEDULE**

<i>Type of Vehicle</i>	<i>Fees (RM)</i>
1. Motorcycle, motorcycle with side car, scooter and three-wheeled scooter, motorcar	5.00 per day or part thereof
2. Other types of vehicle	10.00 per day or part thereof
